## **E. REPORTS & PRIORITY ITEMS**

# 1. Chief's Reports

a. 2024 Annual Report to the Community

The Chief advised that the 2024 Annual Report to the Community is being publicly released today. The report provides a meaningful overview of the past year, highlighting service delivery, organizational achievements, strategic progress, and the contributions of the DPD team both on the front lines and behind the scenes. It also underscores the strength of the department's culture, built on trust, collaboration, and strong community relationships. While the report fulfills a statutory requirement under the Police Act, it also serves as a key element of the department's ongoing commitment to transparency and public accountability. The Chief expressed pride in the team's work and extended appreciation to the Police Board for its leadership and continued support.

# b. Financial Reports for Year Ended December 31, 2024

The Chief reported a small positive operating variance, with savings from staffing vacancies offset by shortfalls in traffic fine revenue, RCMP integrated costs, and major investigative expenses. All prior year vehicle purchases are complete, with four 2024 vehicle purchases deferred to 2025. Overtime was over budget by approximately \$100,000, primarily due to major files and Canucks playoff-related deployments.

c. 2024 Police Stops Audit Report - BCPPS Reporting Requirements

The Chief presented the 2024 Police Stops Audit Report, as required under BC Provincial Policing Standards and departmental policy. Sixteen stops involving 20 individuals were recorded – a 39% decrease from the previous year, aligning with provincial trends. All stops were found to be lawful and compliant with policy, with no systemic inequities identified. The majority were related to individual safety, with many resulting in referrals through the Community Navigator. The audit fulfills the requirements of Policing Standard 6.1.1.

# d. Community Survey Report

The Chief presented key findings from the 2024 Community Survey, conducted in fall 2024 as part of the BC Provincial Policing Standards. The survey, developed with Dr. Eli Sopow, was statistically valid and included both standardized questions from Public Safety Canada and DPD-specific questions.

Results showed strong community trust in DPD, with high support for fairness, professionalism, and effectiveness. Local confidence in DPD (80%) significantly exceeded perceptions of policing in Canada (40%). Top community priorities included violent crime, intimate partner violence, timely response, property crimes, and auto thefts, while future concerns focused on population growth, traffic, and online scams.

Support for body-worn cameras remains strong (86%), and diversity in ability, language, and gender was seen as important to the community. Most residents trust DPD as an information source over social media or online news.

The results will help shape the 2026 Strategic Plan, with immediate focus on increasing visibility, addressing service gaps, and continuing to build public trust through communication and engagement.

# In response to Board inquiries, it was noted that:

- Survey responses indicated people felt they were treated fairly across all race and genders.
- 68% of respondents rated police effectiveness as "good" to "excellent" on the Likert scale, though no narrative comments were collected.
- The importance of diversity in abilities, language, and age was acknowledged, with a suggestion to include diversity in educational qualifications in future surveys.

## e. CSWP Quarterly KPIs Report - 2025 Q1

The Chief reported that while the Q1 KPI target of improvement in 10 of 12 service areas was not met, the results continue to offer meaningful insights. Despite declines in eight areas compared to 2021, 80% of respondents rated DPD's overall performance as "good" or "excellent." The gap between public perception and operational outcomes—such as decreases in violent crime, property crime, and IPV—highlights the need to balance perception-based and evidence-based measures. This will be a key focus in the development of the next Strategic Plan and future KPI framework.

# In response to Board inquiries, it was noted that:

• The community survey is conducted every three years in alignment with Police Services' expectations, and is not done more frequently due to associated costs.

# Quarterly Crime Statistics Report - 2025 Q1

The Chief presented the first quarterly crime statistics report, noting a 13% increase in person offences—primarily assaults—and a 4% rise in overall property crime, with notable declines in mischief and theft from vehicles. Intimate partner violence dropped by 33%, and both cybercrime and fraud were down. Calls for service increased by 2%, reflecting regional demand. This new quarterly format supports more responsive policing, with future plans to enhance public access through interactive dashboards.

## In response to Board inquiries, it was noted that:

• The increase from 268 to 326 in "theft-other" category was primarily due to mail theft (porch pirates), bike thefts, and general theft of unsecured property.

• When collision patterns are identified, traffic redirects resources accordingly. The Department continues to follow the three Es approach to traffic: Engineering, Education and Enforcement.

# f. HealthIM Annual Report 2024

The Chief presented the 2024 HealthIM Annual Report, noting a rise in mental health-related assessments (441), reflecting increased community need. Most assessments (389) led to Mental Health Act apprehensions, with hospital wait times remaining stable due to strong health partnerships. HealthIM continues to support officer safety, improve communication with hospitals, and enhance care transitions. With full provincial funding and PRIME integration underway, the app is now a core tool in DPD's frontline response to mental health calls.

The Community Navigator has access to the HealthIM app and its data, and works closely
with the Mental Health Unit to support effective information sharing and coordinated
response.



# Ontario Man Arrested for Trafficking Drugs and Possession For Purpose of Trafficking

Delta, BC – A Delta Police Officer observed what he believed to be a drug transaction and started an investigation. As a result, an Ontario man was arrested, and a quantity of cash, cell phones, drugs and weapons were seized.

On March 26<sup>th</sup>, 2025, an officer watched a drug transaction occur at the driver's door of a car, illegally parked in the 5200 block of 8A Ave, Tsawwassen. The officer conducted a vehicle stop and observed multiple additional indicators that the driver was trafficking controlled drugs. The driver was arrested. A search of the car and the driver located a large amount of suspected fentanyl, methamphetamine, cocaine, cash, weapons, jerry cans of gasoline, and a balaclava.

A 20-year-old Ontario man has been released on an Undertaking while the investigation continues. A report to Crown Counsel will follow, recommending charges of possession of a controlled substance for the purpose of trafficking, and possession of a weapon for a dangerous purpose.


# **House Fire Determined Not Suspicious**

# Man Arrested for Multiple Thefts From Cars in Ladner

*Delta, BC* – Thanks to calls from the public, a 37-year-old man of no fixed address has been arrested for multiple thefts in Ladner. Some stolen property has been recovered while other stolen items remain outstanding.

On April 7<sup>th</sup>, the Delta Police were notified of a suspicious male in Ladner. Officers spoke with the male and could not determine an offence. Later, officers determined that same male was responsible for several thefts from cars around the 5500 block of 49<sup>th</sup> Avenue and also the 5300 block of Crescent Drive.

Officers relocated the male and arrested him for theft and possession of stolen property. At the time of the arrest, items were recovered that were believed to be stolen but not yet reported. Additionally, several stolen items remain outstanding.

Officers believe unreported thefts have occurred in this area and victims have not come forward. It is possible officers have already recovered your stolen property and would like to return it to you.

Officers are also looking to recover stolen Milwaukee brand tools.

# Hit and Run Pedestrian Struck Collision

*Delta, BC* – A collision involving a Black vehicle and a pedestrian sent one person to hospital with minor injuries. The driver did not remain at the scene.

**Department Support Services** is under budget \$126,014. This variance is a result of Police Staff vacancies in Fleet, Records, Court Liaison, and Information Technology. Active recruiting is ongoing and some of these vacancies have since been filled.

**Investigative Services** is over budget \$172,724 due to investigative expenditures under the Guns and Gangs Violence Action Fund (GGVAF). Funding has been received from the Province to support the reactive and proactive enforcement related to combatting organized crime activity in Delta.

**Community Services** is under budget \$377,252 due to vacancies in District Community Police Offices, Traffic, and Commercial Vehicle Truck Inspection unit. In addition, BC Highway Patrol funded positions have not been filled pending the transfer of responsibility from the Province.

**Patrol Services** is under budget \$611,305 due to a positive variance in overtime and vacant positions.

**Secondments** are over budget \$78,959 due to additional members seconded to BC Municipal Undercover Program (BCMUP) and Federal Serious and Organized Crime (FSOC) unit.

**Recovered Services** are over budget \$160,854 due to the additional members in BCMUP and FSOC.

**Grants** are over budget \$144,607 due to the GGVAF grant from the Province to support DPD intelligence and analyst staffing related to organized crime files.

**Wage bank accrual** is an accounting entry made by the City to record the liability for unused leave banks such as Vacation, Float, Banked OT, and Statutory Holidays. The 10-year average is \$450,000 and will be accrued quarterly until the actual amount is calculated at the end of the year.

In light of the tragic incident that occurred at the Lapu Day celebration in Vancouver, there has understandably been heightened public concern around safety at public events, particularly as we head into the summer months, when outdoor gatherings become more frequent and wellattended.

The Delta Police Department (DPD) takes these concerns seriously. Our team has a strong and proactive approach to event safety. For every major event in Delta, our team carries out risk assessments and develops custom operational plans in partnership with organizers and other key stakeholders. These plans are designed to support the positive nature of community events while making sure the safety of the public remains front and center.

We recognize that no public event is ever without some degree of risk. Our focus is on identifying and mitigating those risks as much as possible. We do that through careful planning, intelligence gathering, a visible police presence, strong coordination with partners, and a willingness to adapt as new concerns emerge. While no plan can offer absolute certainty, we are committed to doing everything we can to keep our community safe.

In response to recent events, we are taking a closer look at our operational plans in support of various community events. This includes reviewing deployment strategies, emergency coordination and other processes to ensure our approach remains current and effective.

We are also closely following Premier David Eby's recent announcement of an independent commission to review and strengthen public event safety protocols in British Columbia. The commission will identify best practices from other jurisdictions and develop strategies to reduce risk and enhance safety at public gatherings across the province. The province has invited police departments to participate in this process, and DPD will be engaging as part of that consultation. The commission is expected to release its findings by June 2025, in time to inform future event planning. DPD will monitor the outcomes closely and will consider any recommendations that support public safety in Delta.

Like other police agencies in B.C., we are reflecting on what more can be done in light of this tragedy. Public safety is-and always will be-our top priority. We remain committed to continuous improvement and to ensuring that Delta continues to be a safe and welcoming place for everyone. Community members should feel confident attending events this summer knowing that we are doing everything we can to support their safety.

Delta is home to one of Canada's busiest container ports-Deltaport-as well as major industrial areas including Tilbury, Annacis Island, and Boundary Bay Industrial Park. With over 63 kilometers of highway infrastructure connecting to the Alex Fraser Bridge, George Massey Tunnel, and the BC Ferries Tsawwassen terminal, the city experiences consistently high volumes of commercial vehicle traffic. Ensuring that these vehicles meet safety standards and regulatory requirements is essential to protecting everyone who uses our roadways.

Accordingly, the Delta Police Department (DPD) takes a coordinated and strategic approach to commercial vehicle safety. This work spans multiple units, including Patrol Services and the Traffic Section, which includes our Commercial Vehicle Enforcement Unit (CVEU). This unit plays a key role in inspections, enforcement, education, and inter-agency collaboration.

CVEU is led by a DPD officer at CVSA Level 1 certification, a North American standard held by fewer than 15 police officers across British Columbia. While this certification is required for specific inspections, commercial vehicle enforcement at DPD is a shared responsibility.

Officers across the department contribute by identifying infractions, supporting enforcement operations, and responding to public complaints. When needed, DPD also works in partnership with the Province's Commercial Vehicle Safety and Enforcement (CVSE) branch for additional expertise and support.

# CVEU focuses on:

- Targeted commercial vehicle inspections
- Enforcement of Dangerous Goods regulations
- Responding to Traffic Enforcement Priorities (TEPs), including complaints about trucks not using truck routes, parking violations, speeding concerns, and hours and log compliance
- Investigating collisions involving commercial vehicles

Beyond enforcement, the unit plays a key role in public education. CVEU collaborates with CVSE, WorkSafe BC, and other policing partners to deliver information sessions for commercial operators and the public. These sessions include safety presentations, Q&A discussions, and vehicle inspection demonstrations. The next session is scheduled for June 11, 2025, at the DPD's Public Safety Building (11375 84th Avenue). Further details, including exact session timing, will be shared through our social media channels.

DPD is also an active participant in a multi-agency commercial vehicle working group, which includes the RCMP, municipal police agencies, CVSE, and local bylaw teams. Throughout the year, CVEU, along with other members of the DPD's Traffic Section, participate in coordinated Joint Force Operations (JFOs), which are multi-agency events that promote safety and compliance through focused inspections.

The following statistics highlight CVEU's activity in the first four months of 2025. These results are consistent with prior years and align with trends observed across nearby jurisdictions:

Targeted vehicle inspections conducted: 244

• Vehicles placed out of service: 159

• Out-of-service rate: 65%

• Violation tickets and warnings issued: 170

It is important to note that commercial vehicle inspections are not conducted randomly. Officers use training and discretion to focus on vehicles with visible mechanical issues or those involved in traffic violations. The high out-of-service rate reflects this targeted approach, not the industry as a whole. By comparison, large-scale random inspections across North America typically show out-of-service rates around 30%.

A vehicle is placed out of service when it presents one or more serious safety risks, such as:

- Faulty brakes or steering
- Missing brake lights
- Unsecured or improperly labelled Dangerous Goods
- A driver without a valid licence

These standards are defined by the North American Commercial Vehicle Safety Alliance and are consistently applied across Canada, the United States, and Mexico.

DPD CVEU has also investigated two commercial vehicle drivers for impaired driving in 2025 and issued immediate driving prohibitions to both drivers.

- One case involved a container truck driver impaired by drugs
- The second involved a dump truck driver impaired by alcohol

While enforcement remains a necessary focus, it is equally important to acknowledge the many commercial operators who maintain safe, compliant fleets. Their diligence and professionalism support road safety for everyone in Delta.

Commercial vehicle safety is a continuing priority for the DPD. Through targeted enforcement, public education, and partnerships, we remain committed to supporting the safe movement of goods and people throughout our community.

# **DISCUSSION**

# **Strategic Planning for the Future**

The DPD and Delta Police Board have initiated the development of the DPD's next Strategic Plan (2026-2030), with the current plan (the 2022-2025 Community Safety and Well-Being Plan) set to expire at the end of this year.

This new plan represents an important opportunity to define the DPD's future direction, ensuring we remain aligned with operational priorities, modern policing practices, and the evolving needs of our community.

#### **Governance and Oversight**

Under Section 26(4) of the B.C. Police Act, municipal police boards, in consultation with their Chief Constable, are responsible for setting the strategic priorities, goals, and objectives of the police department.

Accordingly, the Delta Police Board is overseeing the planning process and providing strategic guidance. Once the draft plan is ready, it will be brought to the Board for approval. The Board will continue to monitor its implementation, and I will report regularly on progress, just as has been done with the current strategic plan.

As Chief Constable, I continue to lead the development of the new plan and will be responsible for implementing it in 2026 and beyond. The plan will be evidence-led, guided by measurable outcomes, and shaped through meaningful input from the Board, our community, stakeholders and the DPD team.

## **Strategic Planning Approach**

Earlier this year, we began the planning process, supported by a subject matter expert, through a discovery phase. The purpose of this phase was to gather high-quality data and intelligence to guide decision-making. This included a review of:

2024 Community Survey results

- Internal data and operational trends
- Priorities set by Delta City Council and the Minister of Public Safety and Solicitor General

Following the discovery phase, the Board engaged in early strategic discussions to help shape the plan's direction, drawing on its governance role, observations, and the evidence collected to date. This early engagement has been important in highlighting the emerging themes.

We have since completed an employee engagement survey and are now preparing to enter the community partner engagement phase. This phase will involve a series of targeted focus groups based on the key themes that emerged from the prior phases.

While these themes are currently being refined into priorities and have not yet been formally approved by the Board, they reflect both community concerns and internal priorities and are evidence led. Once the community partner engagement plan is finalized, invitations will be extended to key stakeholders whose work aligns with those focus areas.

The Police Board is invited to have one to two members in attendance at the focus groups. A full schedule will be shared with the Board once finalized.

We are making steady progress, and I remain confident that the final Strategic Plan will be completed by the end of 2025. It will include clear, actionable priorities that support a progressive, accountable, and responsive approach to policing in Delta.

On March 25, 2025, the Assistant Deputy Minister and Director of Policing (Director) issued a letter (Attachment A) to all municipal police boards clarifying the expectations under section 28 of the Police Act. This section requires boards to submit their "rules" to the Director. The Director has indicated that the longstanding practice of filing departmental policies (both operational and administrative) does not fulfill the statutory intent of section 28.

A provincial meeting of police board legal and policy advisors was held on April 3, 2025, to explore the implications of this clarification and assess what constitutes "rules" under the Police Act. The preliminary interpretation is that boards should be filing their own governance frameworks-such as procedural rules, decision-making structures, and conduct standards-rather than departmental policies. Though there are other details to be worked out.

Based on this interpretation, the Delta Police Board's Governance Manual, which was submitted to the Province in early 2024 and resubmitted whenever updated, appears to align with the legislative intent. However, to confirm this and ensure no gaps exist, it is recommended that the matter be formally referred to the Governance Committee. The Committee can thoroughly review the Province's clarified direction and report back to the Board with any recommendations.

# Dear Sirs/Madams:

As Director of Police Services, I want to thank you for providing governance and oversight of municipal policing in BC, in accordance with the *Police Act* (the Act).

I would like to take this opportunity to clarify the reporting requirement to my office pursuant to section 28, which reads:

- 28 (1)A municipal police board must make rules consistent with this Act, the regulations and the director's standards respecting the following:
  - (a)the standards, guidelines and policies for the administration of the municipal police department;
  - (b)the prevention of neglect and abuse by its municipal constables;
  - (c)the efficient discharge of duties and functions by the municipal police department and the municipal constables.
  - (2)A rule under subsection (1) is enforceable against any person only after it is filed with the director.

The police board and police department are not required to file departmental policies with my office under section 28. The police board is required to file its rules under subsection (1) with my office pursuant to subsection (2). For example, the board may have a rule about how departmental policies are drafted, reviewed and approved. Board rules can be filed with me via email: <a href="mailto:PoliceBoard@gov.bc.ca">PoliceBoard@gov.bc.ca</a>.

Please note, under section 40 of the *Police Act*, I may request specific departmental information, including departmental policies, for the purpose of superintending policing and law enforcement functions in BC.
